

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://www.akindmindcounseling.com/>, and A Kind Mind Counseling and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to A Kind Mind Counseling include <https://www.akindmindcounseling.com/>. The A Kind Mind Counseling website is an online information practices site. By using the A Kind Mind Counseling website, you consent to the data practices described in this statement.

## Collection of your Personal Information

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through A Kind Mind Counseling's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. ## Sharing Information with Third Parties

- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

## **Children Under Thirteen**
